You have been selected to participate in Schemitzun 2018. The event will be held at the Mashantucket Cultural Grounds on the Mashantucket Pequot Reservation across the street from our Community Center. The address of the Community Center is 2 Matt's Path, Mashantucket CT 06338. The food vendors will be set up in the picnic area behind Dance Circle and Cultural Village. There will be **hot showers** at the dugouts in ball park area for campers and participants.

Set up for all Vendors will begin 8 am Thursday August 23rd. Friday set up 8 am to 3 pm, NO Vehicle traffic allowed on grounds during event. Friday food inspection and safety inspection begins at 11 am. Show begins for Pequot Family Friday 4 to 7 pm, open to public Saturday 10 am to 9 pm with Grand Entry 12 pm & 6 pm, Sunday 10 am to 6 pm with Grand Entry at 12 pm.

Please read exhibitor regulations and return registration form with full fee as soon as possible to insure site as limited space and is on **first come basis**. Please retain the regulation page for future reference. **PLEASE NO personal checks!!!**

EXHIBITOR REGULATIONS

1. **Native American made crafts.** Imported merchandise will not be allowed. **Our Council has asked that we not allow sales of costume regalia, particularly the chicken feather headbands or headdresses.**
2. **The Powwow Committee reserves exclusive rights to sell Soda, Flavored Waters Gatoraid and Water. No other vendor will be allowed to sell Sodas, Flavored Waters or Gatoraid, Water during event.**
3. Vendor space is very limited. **Full vendor fee** must be received with registration **to insure site. Partial payment will not insure space!** Sorry NO REFUNDS.
4. Exhibitors must have federal or state tribal identification. **Only invited exhibitors will be allowed to exhibit.** If someone is sharing your booth their name must be on registration with a copy of their Tribal affiliation and contact information. **NO WALK IN VENDORS!**
5. Exhibitors must be open during designated hours as determined by the Committee.
6. We ask that you setup within your designated space without blocking the walkways with extra tables or racks.
7. Committee reserves the right to refuse any exhibitor. Furthermore, the Committee may eject any exhibitor who the Committee determines is not in compliance with the rules and regulations.
8. In the event that an exhibitor is ejected, there shall be no refund of exhibitor's fee. The exhibitor shall promptly remove themselves and their goods from the grounds.
9. Security will be provided for the event, however each exhibitor is responsible to maintain the security of their own exhibit space and safeguard their property. The Committee shall have **NO RESPONSIBILITY** for loss of goods, theft or damage to person or property.
10. The Committee reserves the right to verify all registration or other information provided by any exhibitor. Failure to provide written verification of any such information may be grounds for disqualification from participation, or ejection from the grounds.
11. The Committee reserves the right to approve any and all signs or displays exhibited. Exhibitor agrees to remove or change any signs if requested by the Committee. **Check-in and Setup will begin 8 am Thursday August 23rd and Friday, 8 am until 2 pm.**
12. There is **no electric** power available in the exhibitor area. Hours of operation of the event are based on available daylight. Exhibitor may bring portable generators for electricity.
13. All electrical cords must be UL rated for outdoor use. All lights must either be caged, or higher than eight feet.
